In furtherance to application and subsequent correspondence and
inspection of school-

I, Education Officer (Primary), Zilla Parishad, Aurangabad, do
hereby grant recognition to Mula Education Society, Sonai's, Ace
Academy, C 7/8, Opp. To Bombay Forging, Ratnaprabha Motors Road,
Chikalhana MIDC, Aurangabad, Tq. & Dist. Aurangabad, to its original
class Std. I to VIII English medium, from the period 01 April, 2022 to 31
March, 2025.

This permission is subject to following terms and conditions-

1. Period of getting recognition shall not be extended. In any
situation there shall be no binding for recognition or affiliation
after VIII Std.
2. Relevant provisions of Right of Children for Free & Compulsory
Education Act, 2009 (Annexure I) and provisions of Rules, 2011
(Annexure II), shall be complied with.



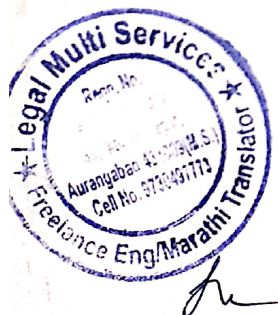
3. 25% of admissions shall be made from backward class and disadvantaged class of society and free and compulsory education shall be given to these children upto primary level; this percentage of admission shall be also applicable for pre-primary school.
4. School shall get finance assistance for admissions as given in para 3 above as per provisions of Sec. 12(2) of said Act, for which school is required to open separate bank account.
5. Society/school shall not charge any capitation fees. No interview of child or his parents shall be allowed.
6. Admission to child shall not be denied on any ground such as caste or creed and shall be irrespective of place of birth.
7. (One) Once admission is given to child, he/she shall not be hold in the same class or he/she shall not be removed from school till his primary education is completed.
(Two) No physical punishment or mental torture shall be inflicted to any child.
(Three) Till child completes his primary education, he/ she shall not be forced to pass any board examination.
(Four) Every student shall be given prescribed certificate under Rule 23 who has completed primary education.
(Five) Handicapped student or student requiring special assistance shall be given assistance as per law.
(Six) As per Rule 23(1) candidate holding requisite qualification shall be appointed as Teacher. However, on the date of enforcing this rule, if such teacher is already appointed, then he/she must acquire that qualification within 5 years.
(Seven) Teachers shall discharge duties as mentioned under Sec. 24(1) of said Act.
(Eight) School shall ensure that, its teachers are not involved in tuitions.
8. School shall follow syllabus prescribed by concerned Board.



9. School will give admission to the students in consideration of physical facilities available in the school as prescribed Sec. 19 of said Act.
10. School shall follow standards given under Sec. 19 of said Act. During last inspection following amenities are available in the school.

13. Society running the school must have registered under the provisions of Society Registration Act, 1860 (Act No. 21 of 1860) or under the provisions of Bombay Trust Act, 1950.
14. School shall not be run in such a manner to advantage any individual, group or group of persons or personal gain of any person.
15. Accounts of school shall be audited and copy of annual accounts shall be forwarded to District Education Officer.
16. Your school has been given code No. (27191002310) this number shall be invariably be used for future correspondence.
17. School shall furnish any report or information as may be demanded by Director of Education/ District Education Officer. Whenever any discrepancies are noticed by Govt. or local authority, school shall remove the same.



18. Society registration shall be renewed from time to time.
